



Strengthening Organizations' Fund Development Planning – Fund Development Institute for DYCD Contracted Organizations **Deadline Extended – Monday, October 31, 2022**

The ever-changing funding climate and the ongoing impact of the COVID-19 pandemic, require organizations to develop a strong and diversified fundraising strategy, and to collaborate with all internal stakeholders.

This <u>seven-session</u> institute including <u>individualized coaching and follow-up</u> is designed to address the challenges inherent in creating a diversified and sustainable fundraising plan and involves senior leadership in building a culture of philanthropy and developing strategies for resource diversification. Participants learn practical, field-tested strategies and tactics that can be easily replicated and expanded to suit organizational needs and size. A culture of accountability is fostered through the creation of a peer mentor network and the assignment of practical exercises with report out requirements.

Agencies receive:

- Techniques for building a culture of philanthropy and cultivating donors
- Clear organizational messaging -in person, in print and online
- Strategies and retreat activities for engaging board members in fundraising
- Tools for creating a <u>fundraising plan</u> including foundation, corporate, individual support
- Stakeholder training to successfully make an ask
- <u>One-on-one coaching during and after institute</u> to assess the strengths and weaknesses of their development departments and provide guidance for strengthening departments
- Access to a <u>peer network</u> to share resources and ideas
